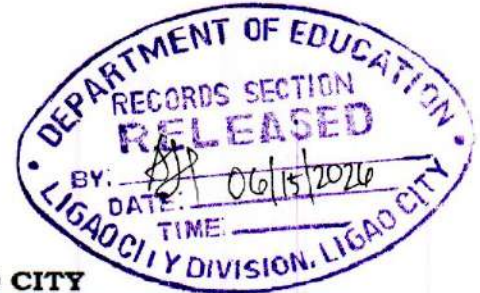

1. In reference to Memorandum OM-OUGOPS-2025-09-1307 titled "**Conduct of the Orientation-Workshop on Inclusive Sports**," this Office informs the field of the participation of Region V delegates in the activity to be held on June 21-24, 2026 at Baguio Teachers Camp.
2. The activity aims to equip facilitators, educators, and sports stakeholders with the competencies needed to promote inclusive sports programs and ensure the participation of learners with diverse needs.
3. The participants from Region V shall consist of the Chief Education Program Supervisor of ESSD; Regional SNED Focal Person, one (1) Division Special Needs Education (SNED) Focal Person from each Schools Division Office; and one (1) MAPEH Supervisor from each Schools Division Office, please refer to Enclosure 1.
4. All identified participants are required to bring an approved Travel Authority and a Medical Certificate indicating that they are medically fit and are ready to perform physical fitness activities and practical sessions.
5. In case the designated Division SNED Coordinator and/or MAPEH Supervisor are unable to participate due to health-related concerns, the SDO shall designate a replacement from among Curriculum Implementation Division (CID)-based personnel to attend and participate in the required activities of the orientation. Notwithstanding their non-attendance, the originally designated personnel shall remain responsible and are expected to be actively involved in the implementation of inclusive sports programs in the division.
6. Expenses related to the conduct of the Orientation-Workshop, including food, accommodation, supplies, materials, venue rental, and other incidental costs, shall be charged against the FY 2026 Physical Fitness and School Sports Funds, subject to existing accounting and auditing rules and regulations. Travel and incidental expenses of participants shall be charged against local funds.
