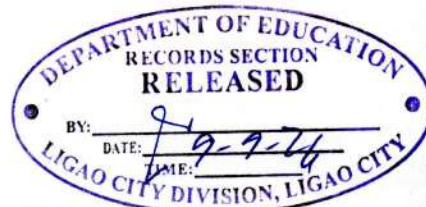

In accordance with DepEd Memorandum No. 002, s. 2026, titled *Implementing Guidelines of the Kaagapay Program: Empowering the School Community for Values Formation, Learning Support, and Bullying Prevention*, this Office will conduct a Regional Orientation and Workshop on the Kaagapay Program on September 29-October 1, 2026, at a venue to be announced later.
2. At the end of the Orientation and Workshop on the Kaagapay Program, participants are expected to:

 - e. Foster collaboration among the Regional Office, Schools Division Offices, schools, parents, and partner stakeholders in creating safe, inclusive, and learner-centered environments that support improved learning outcomes
